FOREWORD (1971)

<u>Significance</u>. The papers of Crawford and Louise S. Hill contain correspondence, personal papers, and business records of Mr. and Mrs. Crawford Hill, records of the estates of Crawford Hill, Cora Cowan, and Mary B. Neely; and business records — correspondence, legal documents, tax and bank records, minutes of directors' and stockholders' meetings, financial statements, securities and real estate transaction, ledgers, journals, stock certificate books, and related materials — for the Boston and Colorado Smelting Company, the Denargo Land Company, Hill Land and Investment Company, and Hill Securities, Land and Development Company.

The papers of Crawford and Louise S. Hill constitute a comprehensive record of the business interests and activities of Crawford Hill from about 1899 until his death in 1922, and of his wife until her demise in 1955.

The Boston and Colorado Smelting Company, organized by Nathaniel Peter Hill and eastern capitalists in 1867, was the principal source of the Hill family's wealth. The enterprise suspended operations in 1909, and was liquidated over a period of years, the formal dissolution occurring in 1950.

The Denargo Land Company, formed in 1887 by C. C. Converse, J. W. Converse, E. S. Converse, J. W. Merrill, G. d. Edwards, Henry R. Wolcott, Edward O. Wolcott, General William J. Palmer, and N. P. Hill, purchased land immediately north of Denver in the vicinity of the Boston and Colorado Smelting Company's newly-opened Argo plant for the purpose of improving and selling real estate at a profit. The enterprise enjoyed large returns prior to 1090, when the smelter ceased operations, and remained in business until December, 1947, at which time the directors ordered a final distribution of assets to shareholders and the formal dissolution of the firm.

The Hill Land and Investment Company was incorporated September 24, 1900, by Mrs. Nathaniel P. (Alice) Hill, Crawford Hill, Isabel Hill, and Gertrude Hill Berger, the wife and children of N. P. Hill, deceased. The purpose of the enterprise was to acquire and manage the properties bequeathed by N. P. Hill to his heirs. The assets of the corporation included property in Denver and in Fremont and Pueblo counties, plus interests in numerous firms in which the elder Hill had investment and managerial interests during his lifetime. The family holding Company was dissolved January 21, 1946, at which time its assets consisted of \$96,163.79 in cash and 5,688 shares of the capital stock in the Dolly Varden Mining Company

The Hill Securities, Land and Development Company was incorporated December 22, 1925, for the purpose of managing the estate of Crawford Hill in the interest of his wife and heir, Louise S. Hill. The Company administered the estate's large holding of share capital in numerous enterprises as well as a substantial amount of real estate in Denver.

As secretary of the Hill Land and Investment Company, and the Hill Securities, Land and Development Company, O. H. Liese played a prominent role in the administration of Louise S. Hill's business affairs. Probably for this reason he was named the executor of the estate of Cora E. Cowan, Mrs. Hill's long-time personal maid, who upon her death left an inheritance of approximately of \$18,000 to her surviving relatives.

Louise S. Hill served as the executrix of the estate of her sister, Mary B. Neely of Memphis, Tennessee. The entire estate, except for bequest, legacies and expenses amounting to \$120,770 was left to Mrs. Hill.

The papers of Crawford and Louise S. Hill are a valuable source of information about the historical development of Denver and of Colorado. The socially and politically prominent Hill family played key roles in the economic activities of the city and the state. The remarkably complete records of the Boston and Colorado Smelting Company, the Denargo Land Company, the Hill Land and Investment Company, and the Hill Securities, Land and Development Company, together with the personal papers of Mr. and Mrs. Crawford Hill, reveal one family's influence over a period of more than a century.

<u>Provenance.</u> The papers of Crawford and Louise S. Hill were given to the State Historical Society of Colorado in December, 1963, by Virginia Lese, executrix of the estate of O. H. Liese. The collection is accessioned with the number 33931 in the 1967-1971 accession book of the Library of the State Historical Society of Colorado.

An addition to the collection was given by Elinor Dorrance Ingersoll (first wife of N. P. Hill, Jr.), May 31, 1977. The addition contains five scrapbooks.

The son of Nathaniel Peter Hill, founder of Colorado's smelting industry, Crawford Hill came to Colorado Territory in 1867 and attended grammar school in Black Hawk. He prepared for college in the English and Classical School, Providence, R. I., and graduated with a B.A. from Brown University in 1885. In August of that year he returned to Denver where he worked for four years in the business office of the Denver Republican. As a businessman he subsequently served as president of the Denargo Land Company, the Hill Land and Investment Company, the Republican Publishing Company, and the Boston and Colorado Smelting Company in liquidation. He was also treasurer of Inland Oil and Refining Company, and secretary of the Dolly Varden Mining Company, as well as serving, at one time or another, as director of the Mountain States Telephone and Telegraph Company, and the First National Bank of Denver. As a civic leader he was a director of the Young Men's Christian Association and the Denver Museum of Natural History. With the rank of Colonel he also served on the military staff of Governors John L. Routt and Albert W. McIntire. Crawford Hill was a life-long Republican and served as the alternate delegate to the Republican National Convention at Philadelphia in 1900, as well as chairman of the state delegation to the convention in Chicago eight years before.

Crawford Hill had two sons, Nathaniel Peter Hill was born January 1, 1896, and Crawford Hill, Jr., December 9, 1898.

Louise Sneed Hill was born in Henderson, N. C. After the death of her parents she resided with a sister, Mary B. Neely in Memphis, Tenn. While visiting in Denver in 1893 with relatives, Capt. and Mrs. William D. Bethell and Mrs. J. M. Foster, Miss Sneed met Crawford Hill. Two years later they were married in Memphis. Their first home in Denver was at Fourteenth Avenue and Cleveland Place. Ten years later they moved into a new structure at 969 Sherman Street. Determined to become the community's social leader, she ruled over the "smart set" with an iron hand for more than thirty years. She was known in her later years as "The Dowager Queen of Denver Society." She wrote the city's first Social Register and organized the "Sacred 36 Families." Her afternoon dances and banquets featuring orchestras were the height of fashion, and she entertained distinguished guests, among President William Howard Taft who stayed at the Sherman Street mansion during a visit to Denver.

In 1940, Mrs. Hill moved from her home the Brown Palace Hotel where she lived the last fifteen years of her life. Upon her death her two sons, Nathaniel P. and Crawford, divided her estate valued at more than five million dollars.
