BIOGRAPHY

Nathanial Peter Hill was born in Orange County New York, February 18, 1832, and was the third of seven children. He graduated from Brown University in 1857 and from 1859 to 1864 was Professor of Chemistry of the institution. In 1864 capitalists from Boston and Providence sponsored Hill for a trip to Colorado Territory to evaluate mineral resources. In Denver he met Ex-Governor William Gilpin and became a number of an expedition to check mineral deposits on Gilpin's newly-purchased land.

N.P. Hill returned to Colorado twice in 1865, once in 1866, travelled to Europe in 1865 and 1866 to evaluate new methods of milling metals, and finally moved permanently to Colorado in 1867 when the Boston and Colorado Smelting Company - backed by capitalists of Providence and Boston - began work in Black Hawk, Colorado.

In 1871 Hill was elected Mayor of Black Hawk, and in 1872-73 he was a member of the Territorial Council. Hill, a republican, was elected to the United States Senate in 1879 to succeed Jerome B. Chaffee and he remained in the Senate until 1885. In 1891 he was appointed by President Harrison as a member of the United States delegation to the International Monetary Commission.

N.P. Hill was president of the Colorado Smelting and Refining Company and the Denargo Land Company, and was also owner of the <u>Denver Republican</u>. In July of 1860 N.P. Hill was married to Alice Hale. Mrs. Hale is known as the creator of the kindergarten system in Denver and was active in the YWCA and the Mt. Vernon Ladies Association. Three children; Crawford, Isabel, and Gertrude, were born to Mr. and Mrs. Hill.

FOREWARD

Significance - The Hill papers consist almost entirely of notebooks and scrapbooks kept by Mrs. N.P. Hill. The materials of greatest value are the notebooks of letters from N.P. Hill to his wife which were copied by her and illustrate three of Hill's trips to Colorado. The papers also contain personal letters from N.P. Hill to his wife during his 1866 trip to Europe.

The content of the Hill correspondence is especially valuable for its descriptions of the travel accommodations and conditions between New York and Denver, the early mining facilities in Colorado (especially in Central City area) and the sights and personalities of Territorial Colorado, Denver, and Central City.

The N.P. Hill collection supplements other Hill family collections: Alice Hale Hill, 308; Crawford and Louise Hill, 309; N.P. Hill II, 923; and Alice Hale Myatt, 938.

<u>Provenance</u> - The materials which compose the N.P. Hill collection were given to the Library of the State Historical Society of Colorado in 1956 by Hill's granddaughter, Mrs. Alexander Barbour.

The Collection consists of original pieces of correspondence, two notebooks, three photographs, and other miscellaneous material. The notebooks contain copied letters from N.P. Hill to his wife, diary entries, and other materials which reflect the personal life and interests of the Hill family.
