Abstract Born in Pennsylvania on March 18, 1868, Orren Allen moved to Colorado

in 1879 with his parents. While living in Colorado, Orren's Father, George

Washington, practiced law for both the District Bench and was Chief Justice of the Colorado Supreme Court. Pursuing a degree in mining engineering, Orren attended M.I.T. but did not graduate. In 1924, Orren was hired as the Chief Inspector for the Moffat Tunnel while serving as

Justice of the Peace and Postmaster in East Portal, Colorado. After the construction of the Moffat Tunnel, Orren stayed active in mining and petroleum. He died on October 5, 1940 after marrying his wife Glenn

Scott Barr earlier that year. In the collection, Papers of Orren Allen,

correspondence and documents are included detailing the Moffat Tunnel, mining and petroleum in Colorado, speeches, and receipts and bills

between Orren and his brother Bill along with business colleagues for the

construction of the tunnel.

Biographical Note

Born in Pennsylvania on March 18, 1868, Orren Allen moved to Colorado with his parents in 1879. Here, his father, George Washington Allen (1843-1928), practiced law, served two terms on the District Bench, and was elected Chief Justice of the Colorado Supreme Court in 1916,

Orren (Brick) Allen attended the Massachusetts Institute of Technology. According to the Denver Post (Oct 6, 1940), he earned a degree in mining engineering. Letters from M.I.T. in FF 39 seem to indicate that he was a "former student" but not a graduate. In 1913 he was engaged in drilling and testing for copper in New Mexico. In 1918 and as late as 1928, he had planned to build and operate a garage in Denver. He was appointed Chief Inspector of the Moffat Tunnel in 1924; concurrently he served as Justice of the Peace and Postmaster in East Portal, Colorado. When the camp was abandoned in 1927, Allen returned to Denver.

After Judge G.W. Allen's death, Orren and his brother, George W. (Bill) Allen, tried for years, apparently unsuccessfully, to establish a memorial to their father at the State Capitol. The Allen brothers wanted the memorial to be in the form of a window, but the idea was rejected.

"Brick" Allen maintained an active interest in mining, petroleum, other investments, and inventions. Unfortunately, these and his real estate activity yielded little in the way of financial success.

After years of failing health, he died in Denver on October 5 1940, His only survivors were his brother Bill, his nephew Ralph, and his widow, Glenn Scott Barr Allen, whom he had married in late February or early March, 1940

Scope and Contents note

Orren Allen, the son of Colorado Supreme Court Justice George W. Allen, lived in Colorado from 1879 until 1940. The Collection reflects the diversity of his interests. Allen's dedication to his work as Chief Inspector of the Moffat Tunnel is apparent in his correspondence and in the copies of documents he retained.

The papers span a period of approximately fifty years, from 1885 to 1940. They are arranged chronologically within categories that vary widely. Following correspondence, the most significant of these are documents pertaining to mining (FF 43-52), petroleum (FF 53-55), Judge G.W. Allen's

speeches (FF 56-71), and detailed information about the Moffat Tunnel (FF 72-75). Hotel, Public Service, telephone, water, and other bills, lists of expenditures, and receipts provide interesting economic data. Another source of information about the Moffat Tunnel is to be found in McMechen's *The Moffat Tunnel of Colorado* (Denver: Wahlgreen, 1927).
